- Time Standards There are no minimum Time Standards for this meet.
- Entry times shall be in short course yards (Y) achieved since January 1, 2024. No Converted Times will be accepted. No Converted Times will be accepted. Please estimate times.
- There are no entry limits.
- All events will be swum fastest to slowest, combining genders.
- The nature of this meet is a virtual challenge that will be contested in each of the six (6) commissions on various dates. Each of the meets from the six (6) commissions will then be combined into a single meet and scored. Should an athlete choose to participate in more than one commission, their fastest time will be used when combining and scoring.
- If the Virtual Distance meet is being conducted on the same day as another meet, per USA Swimming Rules 102.2, the swimmer may compete in not more than six (6) individual events per day inclusive of all meets.
- Athletes from outside the Ohio LSC are invited to attend; however, they will <u>not</u> be eligible for OSI Virtual Distance Awards. They are eligible for any local awards the meet host chooses to distribute.
- Each participating athlete will be required to provide at least one (1) timer and a counter (if desired). Parents will be allowed on deck to time and/or count for their athlete(s).

Location:	Butler Aquatic Center, Hathaway Brown School 19600 North Park Blvd, Shaker Heights, OH 44122. The pool is located across from the tennis courts off Sherbrook Road.			
Facility:	25 yards by 8 lanes, electronic timing and handicap accessible seating, continuous warm-up in the diving well, locker rooms, close parking (street parking is available on Sherbrook Rd, the lot adjacent to the pool and the front lot near the main entrance). The average depth of the pool at the start is 6 feet 9 inches and turn end is 5 feet. The host will ensure the required course dimensions.

Organization Regulations/Waivers USA Swimming At a sanctioned competitive event, all USA Swimming athletes must be under the supervision of a USA Swimming Rules member coach. Arrangements for coach supervision must be made in advance of the meet. Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. The use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms. Use of cameras, cell phones or any other recording device is not permitted immediately behind the starting blocks at either end of the racing course(s) during race starts, competition and warm-ups. Please refer to the Safe Sport section of the Ohio Swimming, Inc. policies and procedures for further information regarding the use of visual recording devices. Deck changes are prohibited. Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. Flash photography is not permitted at the start of any race. All applicable adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy (MAAPP) and that they understand that compliance with

the MAAPP policy is a condition of participation in the conduct of this competition.

Organization Regulations/Waivers Safe Sport 360 The U.S. Center for Safe Sport program is a comprehensive abuse prevention program dedicated to creating a healthy and positive environment free from abuse for all its members. Components of the program include, but are not limited to, providing education and training, enforcing policies (such as the Minor Athlete Abuse Prevention Policy), rules and best practice guidelines, promoting healthy boundaries and mandatory reporting of violations. The Minor Athlete Abuse Prevention Policy (MAAPP) prohibits Applicable Adults (as defined) from having one-on-one interactions with minor athletes which are not within an observable and interruptible distance from another adult. Applicable Adults are required to abide by this policy in full during this meet. (www.usaswimming.org/maapp) Pursuant to USA Swimming Rules and Regulations and federal law, it is every member's responsibility to immediately (i.e., within 24 hours) report any incident of child abuse, including physical or sexual abuse, to law enforcement and the U.S. Center for SafeSport. Reporting must occur when an individual has firsthand knowledge of misconduct or where specific and credible information has been received from a victim or knowledgeable third party. A report to the U.S. Center for SafeSport may be made via telephone at 833-5US-SAFE (833-587-7233) or online at www.uscenterforsafesport.org/report-a-concern. Various state laws may also require reporting to law enforcement or to a designated child protection agency. All athletes aged 18 and older must complete Athlete Protection Training in order to be a USA Swimming registered member in good standing. Any athlete who turns 18 on or after the first day of the start of competition, who has not completed Athlete Protection Training by the first day of competition, will be prohibited from participating in the competition until such time as all membership requirements are completed. Times achieved by an athlete who turns age 18 on or after the first day of competition, who competes in this USA Swimming sanctioned event without completing this membership requirement, will NOT count for qualification or recognition. This includes participation as a member of a relay. For information on how to report other alleged violations, including without limitation, the USA Swimming Code of Conduct, and the Minor Athlete Abuse Prevention Policy, please visit www.usaswimming.org/report Ohio State Laws that Ohio's Return to Play Law (ORC 3313.539 and ORC 3707.511) requires that coaches and referees either (1) complete are applicable to a free online training once every three (3) years in recognizing the symptoms of concussion or (2) hold a pupil-activity **Ohio Swimming** program permit from the Ohio State Board of Education. Free online concussion training is offered through the National Federation of State High School Association and Centers of Disease Control. Training links can be found at sanctioned events www.swimohio.com under Safe Sport>Concussion. There will be the required number of certified lifequard(s) on duty at all times at this meet per Ohio Administrative Code 3701-31-04-E-4. Per USA Swimming Rule 102.8.1F, 12 & Under athletes may not compete in Technical Suits at this meet. Please refer to **Technical Suit Ban** the USA Swimming rulebook for definitions of a technical suit. Waiver/Release By entering this meet, you are granting permission for the names of any or all of your team's swimmers to be published on the internet in the form of Psych Sheets, Meet Results, or any other documents associated with the running of this meet. All participants agree to be filmed and photographed by the host club approved photographer(s) and videographers and to allow the right to use names and pictures before, during, or after the meet such as in public psych sheets, heat sheets, and results or featured on the host club or OSI website or social media or in public broadcast of the event via television or webcast. Parents and guardians of minor swimmers who do not wish their swimmers to participate in interviews or have individual pictures featured on any media should inform their team's head coach and the Meet Director prior to the meet. **Deck Access** The Meet Director and Meet Referee at each site reserve the right to limit deck access in the event of overcrowding, inappropriate behavior or for any reason concerning the safety of the efficient operation of the meet. USA Swimming Rules of Conduct will be strictly enforced. Proof of Non-Athlete Registration does NOT grant access to the pool deck at any time. Only Volunteers, Coaches and Officials signed up to work/attend the event will be permitted on deck. **Code of Conduct** Any individual who exhibits a behavior of a threatening, abusive, or derogatory manner toward an official or member of meet operations is subject to immediate removal and further expulsion from the meet. Coaches will be notified of the actions of their respective teams. Good sportsmanship is expected at all times. Bullying or taunting, foul language or derogatory behavior will not be tolerated and will be subject to immediate removal. All volunteers, spectators, coaches, officials and meet staff are expected to be respectful of others.

• The Ohio Swimming Code of Conduct governs this meet. The purpose of the Zero-Tolerance Code of Conduct Policy is to establish consistent expectations across the LSC in the best interest of our Athletes and Sport. Ohio Swimming is committed to creating a safe and fair environment for all of its athlete members. This policy is to be used as a guide to promote a positive environment and good sportsmanship at meets and events conducted in the geographical boundary of Ohio Swimming. This information will be distributed at registration, posted throughout the venue, announced on a regular basis before and during the meet, and monitored jointly by the Meet Director and Meet Referee (or their special designees). Flagrant violation of these procedures may result in a disqualification from the meet for unsportsmanlike activity. Encourage your swimmers to cooperate with marshals.

Competition Guidelines:	 This meet will be a timed finals meet. This meet will be contested in SCY. No Clerk of Course will be available for younger swimmers. Events will be contested as combined gender events. Heats will be swum fastest to slowest. Warmup-Start times will be published after the entry deadline. 8 lanes will be used for competition. 				
Awards:	 After all virtual meets have been contested, the results will be compiled and posted on the OSI website. Medals will be awarded for the top three (3) finishers in each age group (8 & under, 9-10, 11-12, 13-14, and 15 & over) Only athletes registered in the Ohio Swimming LSC will receive OSI awards. Awards will be given at the next OSI Banquet.
